Security Processes

This is an 18+ venue. All customers must provide a valid physical ID on arrival. We operate a strict No ID / No Entry policy. ID scanners are in operation at all events

All guests will be body & bag searched when entering our venues.

To make this experience as comfortable as possible, guests have the freedom to choose the member of our security team they wish to be searched by before entering.

Our team reserves the right to refuse entry to those who refuse to be searched as well as those who are unable to provide suitable valid & physical ID. You will be refused entry if you are judged too intoxicated or in possession of illegal/prohibited items (full list below).

Illegal / prohibited items will be permanently confiscated, and the holder will be liable for prosecution. No refunds will be issued for refused admission. If you feel that you need to bring a prohibited item with you, for dietary, health, wellbeing - or other reasons we may not be aware of - please get in touch with us before your visit: info@nighttales.co.uk

Our security team works with us to support us in reducing harm & keeping guests safe. They have the right to work without abuse. Greet them with a smile and ask them their name; they want to enjoy their night too!

Our venue staff and security team have undertaken independent training from SafeOnly who provide welfare & consultancy to LGBTQIA+ events and venues such as Dalston Superstore, Body Movements Festival, FEEL IT & Klub Verboten. This training informs our team on welfare, respecting pronouns, gender and sexual orientation.

All staff & security members are given a copy of the venue policy to contract their acceptance of understanding of its detail and that any behaviour contrary to our policy will be met with immediate dismissal.

PARKING AND DELIVERIES • We do not have full time parking at the venue, however for events we can give you a parking permit upon request for up to 3 vehicles maximum per event. We can have load ins and loads out for 20-minute max. If needed for longer then please speak to the manager on site.

SMOKING • Smoking (including the use of e-cigarettes) is permitted in designated outdoor smoking areas only. If you are caught smoking anywhere except for the designated outdoor smoking areas, you will be ejected from the venue without a refund.

DRUGS POLICY • We operate a strict zero tolerance drugs policy. Anyone found in possession of illegal substances will be refused admission, ejected from the venue and may also be liable for prosecution. We reserve the right to pass your details on to the relevant authorities should we consider an offense or criminal act has taken place.
